## Product description

EUROTUBI galvanized pressfittings with V profile made of carbon steel available in following dimensions: 12, 15, 18, 22, 28, 35, 42 and 54 mm. The fittings have o-rings made of EPDM and are designed to leak in unpressed condition.

The pressfitting is mounted on tube of carbon steel. Installation is carried out using a tool approved by the holder of the approval. The pressfittings have red press indicator.

## Intended use

The pressfittings are intended for joining of carbon steel tubes in closed heating systems where the incoming water quality is comparable with water from municipal facility. Water temperature shall not exceed 95°C and maximum operating pressure is 1,0 MPa.

## Trade name

EUROTUBI pressfitting system with V profile made of galvanized carbon steel with LBP function.

## Approval

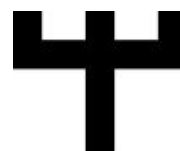
